I will put myself in self-monitored home quarantine or quarantine in a suitable accommodation, the costs of which I will cover myself, without undue delay for ten days and I will not leave the quarantine accommodation during this period. I may take a SARS-CoV-2 molecular biological test or antigen test for SARS-CoV-2 no earlier than on the fifth day after entry. I will cover the costs of such a SARS-CoV-2 test myself. If the result is negative, the quarantine shall be deemed to be terminated early.

In the past 10 days I spent time in the **countries / regions listed under Appendix B2 (section 5a and section 7(2))**:

Medical certificate or test result (**only valid with a molecular biological test**) is available: I will put myself in self-monitored home quarantine or quarantine in a suitable accommodation, the costs of which I will cover myself, without undue delay for ten days and I will not leave the quarantine accommodation during this period. I may take a molecular biological test for SARS-CoV-2 no earlier than on the fifth day after entry. I will cover the costs of such a SARS-CoV-2 test myself. If the result is negative, the quarantine shall be deemed to be terminated early.

Medical certificate or test result is **not** available:

Austrian citizen, EU/ EEA citizen, Swiss citizen, normal place of residence or habitual residence in Austria: I can have a SARS-CoV-2 molecular biological test carried out after entering the country without undue delay, but **within 24 hours at the latest**. I will put myself in self-monitored home quarantine or quarantine in a suitable accommodation, the costs of which I will cover myself, without undue delay for ten days and I will not leave the quarantine accommodation during this period. I may take a molecular biological test for SARS-CoV-2 no earlier than on the fifth day after entry. I will cover the costs of such a SARS-CoV-2 test myself. If the result is negative, the quarantine shall be deemed to be terminated early.

Third-country nationals without normal place of residence or habitual residence in Austria: Entry is not permitted!

Entry is subject to one **of the exemptions under section 5(5)** (humanitarian workers; entry for professional purposes; companion for persons entering for medical reasons; honouring an important obligation required by the judiciary or administrative officials; holders of a legitimation card):

Test result, vaccination certificate or recovery certificate is available.

Test result, vaccination certificate or recovery certificate is **not** available: I will put myself in self-monitored home quarantine or quarantine in a suitable accommodation, the costs of which I will cover myself, without undue delay for ten days and I will not leave the quarantine accommodation during this period. I may take a SARS-CoV-2 molecular biological test or antigen test for SARS-CoV-2. I will cover the costs of such a SARS-CoV-2 test myself. If the result is negative, the quarantine shall be deemed to be terminated early.

**Special regulation for B2 countries/regions (section 5a(2)): PLEASE NOTE:** Only applies to humanitarian workers; honouring an important obligation required by the judiciary or administrative officials; holders of a legitimation card; entry for professional purposes to visit an international establishment; companion for persons entering for medical reasons (**section 5a(1)** applies in cases of professional purposes):

Medical certificate or test result (**only valid with a molecular biological test**) is available.

Medical certificate or test result is **not** available:

Austrian citizen, EU/ EEA citizen, Swiss citizen, normal place of residence or habitual residence in Austria: I can have a SARS-CoV-2 molecular biological test carried out after entering the country without undue delay, but within 24 hours at the latest. I will cover the costs of such a SARS-CoV-2 test myself. I will put myself in self-monitored home quarantine or quarantine in a suitable accommodation, the costs of which I will cover myself, until a negative molecular biological test result is presented.

Third-country nationals without normal place of residence or habitual residence in Austria: Entry is not permitted!

Entry is subject to one of the **exemptions under section 6a** (commuter).

Test result, vaccination certificate or recovery certificate is available: Entry permitted

Medical certificate or test result is **not** available: I will take a molecular biological test for SARS-CoV-2 or an antigen test for SARS-CoV-2 without undue delay, but no later than 24 hours after entering the country. I will cover the costs of such a SARS-CoV-2 test myself.

Entry from **B2 countries/regions** or time spent in one of the following regions in the 10 days before entry: Section 5a(1): molecular biological test and quarantine (see above)

Entry is subject to one of the **exemptions under section 6(1) or section 6(2)** (entry for medical reasons).


**Minor:**

Minors aged between 10 and 18 **without** a medical certificate or recovery certificate accompanied by an adult in possession of a vaccination certificate or recovery certificate at the time of entry: Entry with a test result or the possibility to take a test after entry without undue delay, but within 24 hours at the latest.
