A person who fails to present required certificates is subject to requirements applied to non-vaccinated persons and persons who have not recovered from the disease, a PCR test 72 hours before boarding the carrier's vehicle or entering Latvia, or an antigen test 24 hours before boarding the carrier's vehicle or entering Latvia.  ISRAEL	<b>All vaccinated and non-vaccinated passengers</b> entering Israel who have stayed outside Israel for more than 72 hours <b>must present a medical certificate with a PCR test taken 72 hours before departure</b> . <b>All vaccinated and non-vaccinated passengers</b> must submit an <a href="#">inbound passenger statement</a> no more than <b>24 hours before the departure time</b> of their flight to Israel in order to be able to board, presenting the clearance with the reference number received after submitting the forms on the Ministry of Health Website. <b>Foreign nationals are required to present an entry clearance certified by the Consulate of Israel in the country of origin</b> , the list of the cases in which the entry of foreign nationals into Israel will be exceptionally approved after examination and the protocol that applies can be found <a href="#">here</a> FAQs regarding air travel during COVID-19 ( <a href="#">English</a>   <a href="#">Hebrew</a> ).  JORDAN	Pax requirements: submit <a href="#">health declaration and locator form</a> and present neg. PCR test conducted within 72 hrs prior to departure. Health insurance for non-Jordanians and Aman mobile App is also mandatory. PCR test required upon arrival and each pax has to register and pay the amount of 28 JOD through this <a href="#">link</a> . <b>(There is no option to pay this fee at the departure airport and all pax 5 &amp; over must present a receipt of payment which shall be shown to check-in or gate personnel prior to dept, failure to present receipt may result in travel being refused). PCR Tests are not required for children below 5yo and foreign pax who have been in the UK in the 14 days prior the departure are not allowed to enter. Those from countries on <a href="#">list B</a> must have exceptional arrival authorisation, a negative PCR test of less than 48 hours and undergo a 10-day medical isolation once there. Children 10 and under are exempt. Pax aged 12 and over who are permitted (exceptions apply) must complete the <a href="#">online registration form</a> ( <i>paper forms will not be accepted</i> ), present proof of negative C-19 test taken within 24 hrs prior to departure, be tested for C-19 upon arrival if requested too and stay in quarantine for 10 days.  ROMANIA	All pax arriving from countries/areas/territories with high epidemiological (Red Area) MUST quarantine for 14 days unless: they have been to green countries within the past 14 days, are in transit in Romania for 24h or are vaccinated and 10days have elapsed since the 2nd dose.  SWEDEN	Travel restrictions <a href="#">apply</a> . Foreign citizens over 18 who are permitted to travel to Sweden must present a negative C-19 test, done within 48hrs prior to arrival. Anyone who cannot present a valid negative test will be rejected at the border.  SWITZERLAND	All arrival pax must complete the online <a href="#">Form</a> . PAX (excl. children under the age of 12) must prove that in the last 72hrs they have been tested for sars-cov-2 by means of molecular biological analysis and that the result or the test was negative. If arriving from a country with an increased risk of infection of sars-cov-2, pax must go into quarantine despite a negative PCR test result.  UKRAINE	All foreign citizens and non-residents, without exception, regardless of the country of arrival to enter Ukraine must have a policy (certificate) of insurance issued by an insurance company registered in Ukraine, and covers the costs related to the treatment of C-19, observation, and is valid for the entire period of stay in Ukraine. As well one of the following , a document confirming the receipt of a full course of vaccination against COVID-19 with vaccines included by WHO in the list of approved for use in emergency situations; or a rapid test for the SARS-CoV-2 antigen (RAT) that was done no more than 72 hours before entry; or a certificate of a negative PCR test result done no more than 72 hours before the entry. The test is not necessary for children under 12 years.
